An Act for the better Security of all fuch as are lawfully possed of any Negroes, or other Slaves in these Islands, whereby to secure their lawful Rights, Interest, and Property of and to the same.



THAT whereas feveral Perfons, Inhabitants and others, within few Years laft path have forced and Years last past, have forced and carried away, and also floct and enticed feveral Negroes, and other Slaves, from their Owners and Poffeffors, without any legal Warrant for the fame: For Prevention of fuch evil Practices for the future, We your Majefty's most dutiful and loyal Subjects, the Affembly of these your Majesty's Bermuda or Summer-Islands in America, do most humbly befeech your Majefty, that it may be enacted by your Majefty's Lieutenant Governour, Council and Affermbly, and hereby it is enacted and ordained by the Authority of the fame, That from and after Publication hereof, Perfors entiif any Perfon or Perfons whatfoever within these Islands, shall tempt, intice, cing away, or entertaining perfwade, flock, clandeftinely entertain any Negro, or other Slave, to leave or another slave, abfent themfelves from the Service of their Mafter, Miftrefs, or those by that forfeit whom they are employed, out of an Intent or Defign to fecret or conceal them $\frac{\text{vied by Dif}}{\text{Dif}}$ trefs, Oc. or any of them from their respective right Owner or Owners, or lawful Employers, or employ them in their own Service, or clandeftinely carry or convey them out of these Islands, or in any Manner to defraud the faid Owner or Owners, or Employers of them or any of them, being thereof duly convicted, by their own Confession, or by the Oath of one or more credible Witnesses, made before the Governour or Chief Justice of these Islands for the Time being, or any Two Judges of the Court of King's-Bench, Common-Pleas, Sc. shall be adjudged to pay for every fuch Offence to the Party grieved, who was possefield of every such Negro, or other Slave, the Sum of Twenty Pounds Current Money, to be levied upon the Goods and Chattels, Lands and Tenements of every fuch Offender, and in cafe the Party fo offending shall not be found worth Lands, Goods, or Chattels to the Value aforefaid, then the Judge or

or Judges aforefaid, fhall and may, by Virtue of this Act, adjudge him or them to offending to be Servant or Servants unto the Perfon or Perfons grieved for the Space of Five Years, or to long as until he, the, or they thall make Satisfaction to the Party to wronged or grieved, and thereupon deliver him, her, or them over by Warrant to the faid Party to injured, and make a Record of the fame.

An Inhabitant of this Ifland conveying arco or Perfons, Inhabitants or others, fhall fo tempt, flock, or clandeftinely practher's Slave a- tife upon any Negro or Slave, and him, her, or them, fo tempted, convey way fhall forther's double the away or fend out of thefe Iflands, and fuch Perfon or Perfons, fo offending, Value of fuch be afterwards apprehended and convicted before the Governour, or fuch Judge or Judges as aforefaid, fhall be condemned by the faid Judge or Judges to pay the Owner of fuch Negro, or other Slave, Two Times the Value of him fo

the Owner of fuch Negro, or other Slave, Two Times the Value of him fo fent away as aforefaid, and Execution for the fame (from the faid Judge or Judges) to iffue accordingly; and if the Perfon fo offending has not fufficient Eftate, as aforefaid, then he, fhe, or they, fhall be ordered by the faid Judge br Judges to ferve the Party grieved or injured as aforementioned; any Law, Cuftom or Ufage to the contrary in any wife notwithftanding.
